##### Time and method of identification.

Two Yorkshire Terriers did not have an ID on them. Failure to have official identification applied to each dog does not allow the inspectors to identify the dog and could interfere with the ability to connect medical records and other documentation to the individual dogs. The applicant must ensure all dogs have an ID.

#### 3.10(a)

##### Watering

One of the outdoor enclosures with 3 dogs had a their only water bucket with a layer of ice on the top. When water was presented, the dogs took a quick lick. Lack of water could cause the dogs to become dehydrated or other health issues. Having water available at all times is important to the health of the dogs. The applicant must ensure all dogs have access to potable water at all times.

#### 3.13(a)

##### Veterinary care for dogs.

Although the applicant had the attending veterinarian recently do a hands on exam and rabies vaccination, these were not recorded in the program of veterinary care. Also missing from the program of vet care was the preventative care section. Failure to have these plans could have a negative impact on the health and well-being of the animals. The Program of Veterinary Care must include a frequency of hands on exam, rabies vaccination and appropriate plan of preventative care
