Time and method of identification.

A recently acquired nine week old grey French bulldog puppy has not been officially identified. The puppy does not currently have a microchip or official tattoo and is not wearing an official tag or plastic collar containing the required information. All dogs including puppies need to be identified in order to allow for accurate identification for legal and medical purposes. The facility shall identify all live dogs on the premises using an official method of identification as described in the regulations. The puppy needs to be identified using a microchip, official tattoo, official tag or plastic collar with the required official identification pursuant to Sec. 2.51. Correct by 8/19/22.

3.13(a)

Veterinary care for dogs.

The current written program of veterinary care (PVC) is not complete. It does not include provisions for a complete physical examination of the dogs by the attending veterinarian every 12 months or preventative care and treatment for hair coats/nails/eyes/ears/skin/teeth. In addition the instructions for sampling and treatment of parasites and other pests are insufficient. They do not include instructions for certain organisms (coccidia, giardia), do not include any information on sampling/testing and do not give treatment dosage recommendations. The PVC must be complete and include instructions regarding regularly scheduled visits, annual physical exams, vaccinations, preventative care of

skin/nails/eyes/ears/teeth and sampling and treatment for parasites and pests in order to provide for the health and wellbeing of the dogs. The facility shall ensure that they follow an appropriate PVC that includes all required elements and is developed and documented by the attending veterinarian. Correct by 9/9/22.

3.13(b)

Veterinary care for dogs.

The facility currently does not keep copies of medical records for the dogs. There are no records that include identification of the dogs and the routine husbandry procedures performed on the dogs such as vaccinations and deworming/parasite treatments. In addition, there are no medical records kept for problems identified and treated. Medical records are necessary to document preventative procedures completed and medical diagnoses/treatments provided. The facility shall keep copies of medical records for dogs that include the required information including the identifying information about the dog, all preventative and routine husbandry procedures performed, information about problems identified, treatments/vaccinations administered and results of all tests performed. Correct by 9/9/22.
