Attending veterinarian and adequate veterinary care (dealers and exhibitors).

There is a female Boxer (ID #05- Jasmine, brown and white/approx. 1.5yrs) that had both the right and left ears with swollen, red and inflamed lining of the inner ears. There was a brown greasy material around the outside of the ear canal in both ears. There were round scabs approximately 1/4 inch in diameter on the inside tips of both ears. This dog had a moderate amount of light yellow slightly formed to liquid diarrhea in the outside run.

There was a female Boxer (ID #103, Sadie Girl, Black and white/ approx. 4 yrs old) that had thickening and darkened gray skin on the inside of both ear flaps. There was a thin coating of crusty-flaky white debris overlaying the darkened skin.

There was a scab approx. 1/4 inch in diameter on the inside left ear near the tip. There were areas of hair loss and thickened skin on both the right and left inner and outer ear flaps.

There was a female King Charles Cavalier Spaniel (ID #200, blenheim/liver/white) that had a buildup of moist, brown material in both inner ear canals and there was redness/inflammation to the skin surrounding the entrance to the inner ear canal. There was a superficial scab on the margin of both inner ears.

Inspection Report

The licensee was not aware of the ear problems in any of the regulated animals. The veterinarian had not been contacted for proper diagnosis or treatment of the ear conditions prior to the inspection.

Built up brown material in ears, hairloss, redness/inflammation, thickening, darkened skin, and scabbing can be possible signs that there is a problem with the ears and the dogs are scratching and/or shaking their heads due to possible discomfort, itching and irritation. The lack of timely veterinary care can cause a treatable condition to become chronic and more severe.

-According to the monthly heartworm treatment documentation, all the dogs in the facility did not receive their monthly heartworm treatment in June, August and September of 2022 which is not following their program of vet care.

The lack of monthly heartworm treatments could make the dogs susceptible to contracting heartworm, and the program of vet care advises that heartworm treatments are given monthly.

The licensee must contact a veterinarian for proper diagnosis and treatment of any health issue on the regulated animals, according to the AWA regulations and standards. The program of vet care or any treatment described by the attending veterinarian must be followed according to their directions.

To be corrected by: The attending veterinarian was contacted during the inspection and treatment was prescribed.

The lack of yearly examinations by a veterinairian could prevent early identification of illnesses or other health related problems.

A licensee must have a complete physical examination from head to tail of each dog by the attending veterinarian not less than once every 12 months.

To be corrected by: The licensee contacted the attending veterinarian during the inspection and the exams are scheduled for 11/6/2022.
