#### 2.40(b)(3)

#### Attending veterinarian and adequate veterinary care (dealers and exhibitors).

The facility has given a cattle nutritional supplement, Knock Out, to dog's with diarrhea without consulting with their attending veterinarian on an effective treatment plan. The attending veterinarian was not aware of this treatment being given to dog's with diarrhea. Diarrhea may be a symptom of a intestinal parasites and may cause unnecessary pain and discomfort to the animals.

A mechanism of direct and frequent communication is required so that timely and accurate information on problems of animal health, behavior, and well-being is conveyed to the attending veterinarian. The facility must communicate with the attending veterinarian on all treatment plans for medical ailments including but not limited to diarrhea.

## 2.75(a)(1)

#### Records: Dealers and exhibitors.

The facility is missing the Record of Disposition for Dogs (APHIS Form 7006) for four adult dogs sold on 2-July-2022.

Three Cavalier King Charles Spaniels (#23, #24, #12) and one Poodle (#16) were sold to a facility in Missouri. The transporter took the form to be signed by the buyer and never returned a copy to the facility. Disposition records of animals sold must be accurate and kept up to date to allow APHIS officials to track the animals' movements.

Each dealer shall make, keep, and maintain records or forms which fully and correctly disclose the acquisition information

The facility must accurately create and maintain all disposition records when each dog is transported, sold, euthanized or otherwise disposed of. To be corrected by: From this day forward.

### 3.13(a)(1)

#### Veterinary care for dogs.

The facility's Program of Veterinary Care is missing the frequency in which the attending veterinarian will conduct regularly scheduled visits to the premises where dogs are kept. The facility is having the veterinarian come annually but this is not in writing and approved by the attending veterinarian.

Regularly scheduled premises visits by the attending veterinarian at least every 12 months ensure the adequacy of veterinary care and other aspects of animal care. The facility must develop a plan in writing with the attending veterinarian how often they will visit the premises.

#### 3.13(a)(2)

#### Veterinary care for dogs.

The facility's Program of Veterinary Care is missing the frequency of which the veterinarian will conduct head to tail exams on all dogs. Head to tail exams ensure the dogs with potential medical ailments are identified early by the attending veterinarian to prevent potential pain and discomfort.

The written program of veterinary care must address the requirements for adequate veterinary care for every dealer and exhibitor in § 2.40 of this subchapter and must include a complete physical examination from head to tail of each dog by the attending veterinarian not less than once every 12 months. The facility must develop a plan in writing with the

attending veterinarian for the frequency of head to tail exams on all dogs, no less than every 12 months.

### 3.13(a)(3)

#### Veterinary care for dogs.

At least 8 adult dogs are not up to date on distemper, parvovirus and rabies vaccines. The dogs listed below were either in heat, pregnant or nursing when the other dogs were vaccinated on Rabies on 1-July-2022 and distemper/parvovirus on 10-June-2022. This caused them to need to be vaccinated once the puppies were weaned. The facility was aware these dogs needed to be vaccinated but had not scheduled a veterinary visit for Rabies or vaccinated the dogs for parvovirus/distemper.

Overdue for Distemper, Parvovirus, Rabies:

- -Little Toot #18- puppies left the facility on 16-September-2022.
- -Three Toot #19- puppies left the facility on 16-September-2022.
- -Little Roxie #10- puppies left the facility on 2-October-2022.
- -Amy #22- puppies left the facility on 16-September-2022.

Overdue for Distemper and Parvovirus

- -Tootsie #20- puppies left the facility on 20-August-2022.
- -Amber #11- puppies left the facility between 18-July-2022 and 20-August-2022.

Overdue for Rabies

- -Bella #5- was in heat at the time the vaccines were given but never became pregnant.
- -Izzy #4- was in heat at the time of vaccines given, puppies left the facility this week.

Dogs not kept up to date on vaccines may contract contagious and/or deadly diseases, which may cause unnecessary pain and discomfort.

Each dealer must follow an appropriate program of veterinary care for dogs that is developed, documented in writing, and signed by the attending veterinarian. The facility must follow the schedule for Distemper, Parvovirus and Rabies vaccines written in the Program of Veterinary Care to protect the dogs from these contagious and/or deadly diseases. The facility must vaccinate all dogs in need of the vaccines listed above, keep a written vaccine record and maintain the vaccine schedule in all dogs from this day forward.

To be corrected by: 9-December-2022.

The facility has not tested 10% of the kennel for intestinal parasites (intestinal worms, giardia, coccidia) as listed on their Program of Veterinary Care. Failure to follow the parasite control program approved by the Attending Veterinarian may not properly protect the dogs from parasites and may cause illness to go undetected and untreated, which may cause pain and unnecessary discomfort to the dogs. The facility must follow the approved parasite control testing schedule approved by the attending veterinarian to protect the dogs from parasites and other pests (worms, coccidia, giardia and heartworm) and have 10% of the kennel tested annually.

#### 3.13(b)(1)

#### Veterinary care for dogs.

The facility had the head to tail exams done by the attending veterinarian on all dogs on 1-July-2022, but there is no written medical record with the results/findings and identification of each dog examined during this routine exam.

The lack of medical records makes it difficult to determine if the animals are receiving the preventative medical assessments and if any medical issues were identified. This information is needed for APHIS inspectors to ensure the medical care is being provided by the facility. The facility must complete and maintain updated medical records including

which dogs were examined by the veterinarian and any results or findings. If any medical issues were identified, a
treatment plan must be also created in writing and approved by the veterinarian.
