#### Outdoor housing facilities.

In the outdoor enclosures there is an enclosure containing 4 medium size adult dogs and only 2 plastic shelters. The shelters do not provide sufficient space for 2 dogs to sit, stand, lay down and turn around freely. More shelter space must be provided.

There are 4 enclosures that do not provide enough shaded areas for each of the dogs in the enclosure. One enclosure contains 4 adult dogs, 1 contains 3 dogs, 1 contains 2 dogs and 1 contains 1 dog. It is necessary to provide one or more separate outside areas of shade, large enough to contain all the animals at one time and protect them from the direct rays of the sun. The applicant must provide more shade and maintain at all times.

#### 3.4(b)(3)

#### Outdoor housing facilities.

In the outdoor enclosures one of the shelters does not have a wind break and rain break at the entrance. The wind break and rain break is important to keep wind and rain out of the shelter to provide better shelter for the dogs. Shelters in outdoor facilities for dogs must contain a roof, four sides, and a floor, and must be provided with a wind break and rain break at the entrance and must be maintained at all times.
