Outdoor housing facilities.

There were 2 enclosures housing 4 dogs in outdoor enclosures without bedding in the shelters. According to National Oceanic and Atmospheric Administration (NOAA) the outdoor air temperature for the past 24 hours, in the area was 23 degrees F for a low and high of 42 degrees F with a temperature of 38 degrees F at the time of inspection. The dog shelters were insulated but did not have any bedding. Housing dogs in enclosures without providing a sufficient source to keep them warm increases the risk of stress, hypothermia, illness and discomfort. The licensee must ensure enclosures contain clean, dry, bedding material if the ambient temperature is below 50 degrees F. Additional clean, dry bedding is required when the temperature is 35 degrees F or lower.

Outdoor housing facilities.

The facility has outdoor enclosures with concrete floors, not impervious to moisture. There were 3 outdoor enclosures with 4 dogs that had concrete floors. The concrete floors are not impervious to moisture, therefore cannot be properly cleaned and sanitized. The applicant must ensure all surfaces in contact with animals are impervious to moisture. The applicant must ensure all surfaces must be maintained on a regular basis.

Although the applicant had the attending veterinarian do a hands on exam and do a fecal tests, these were not recorded in the program of veterinary care. Also missing from the program of vet care was the preventative care section. Failure to have these plans could have a negative impact on the health and well-being of the animals. The Program of Veterinary Care must include a frequency of hands on exam, parasite sampling/testing for fecals and heartworm and appropriate plan of preventative care and treatment to maintain healthy and unmatted hair coats, properly trimmed toe nails, and healthy teeth, ears, eyes and skin. The applicant must add the missing plans to the Program of Veterinary Care in order to ensure the animals are receiving adequate veterinary care.

This is a 1st Re-License Inspection for a Class A license. The inspection and exit briefing were conducted with the applicant.

All items must be in compliance within 2 more inspection(s) or by 01/14/2023 or the applicant will forfeit the license fee and must wait 6 months to reapply. Please contact your inspector to schedule your next Re-License Inspection.
