**Attending veterinarian and adequate veterinary care (dealers and exhibitors).**

A white and gold female Shih Tzu, named Petunia with microchip number # 0A02592912, approximately eight years old was found with poor dental health. The licensee noted that he had not noticed her condition. On the right side the upper teeth behind the canine are almost completely encased in a hard brown material. The tooth directly behind the canine tooth has some gum recession. On the left side the far back upper tooth is completely covered in a dark brown material and the gums are red and swollen. The front teeth are three quarters covered in a very thick brown to dark brown material with gum recession seen on almost every tooth. The first upper left front tooth from the midline is also slightly loose. The licensee call and made an appointment for this dog before the end of the inspection. Poor dental health can cause pain and discomfort to the animal as well as lead to further health issues. This dog must be evaluated by a licensed veterinarian for an accurate diagnosis and to develop an effective treatment plan. Each dealer must follow an appropriate program of veterinary care for dogs that includes preventative care and treatment to ensure healthy teeth for all dogs.

Each dealer must follow the already approved program of veterinary care for dogs that is developed, documented in writing, and signed by the attending veterinarian that includes sampling and treatment of parasites and other pests (including fleas, worms, coccidia, giardia, and heartworm).
