Multiple dogs were found with dental issues that must be must be taken to a veterinarian for treatment.

"Cherry" Female Ruby Cavalier ID#7E10110457 had severe tartar on the upper right, with gum loss on a cheek tooth.

"Strawberry" Female Red White Mini Australian shepherd ID#2603014 had severe tartar accumulation on numerous teeth. Strawberry had pale gums and appeared lethargic, and had numerous fleas.

"Misty Blue" Female Blue Merle Mini Australian shepherd ID#7E10110459 had severe tartar primarily on the left side and had a loose lower cheek tooth.

"Teddy" Male White and tan Pomeranian ID# OAO2492902 had severe tartar primarily on the left side.

"Emma" Female Black Merle Mini Australian shepherd ID# OAO2481217 had severe tartar with gum loss on upper left cheek tooth.

"Lace: Female Cream Pomeranian ID#OAO2490462 had severe tartar accumulation on multiple teeth.

"Jim Dandy" Male Sable Shelty ID#956000009878249 had severe tartar accumulation on multiple teeth.

"Afton" #95600009997677 Mini Aussie White and Blue Merle had severe, widespread dental tartar accumulation.

"Strawberry" showed pale gums and lethargy. This is a potential indication of a serious medical problem. She must be

taken to a licensed veterinarian within 2 days to be evaluated and treated appropriately.

Dental disease can have a severe, negative impact on the health and welfare of affected animals. Dental disease can result in pain, tooth loss, decreased appetite, and systemic disease. All 8 dogs must have appointments scheduled within 5 days to treat their dental conditions. The veterinarian should be consulted to determine an appropriate time frame for each dog's actual treatment. All eight dogs must have dental cleaning and appropriate treatment. All dogs must be evaluated by veterinarian within 5 days to determine appropriate treatment.
