Attending veterinarian and adequate veterinary care (dealers and exhibitors).

-On December 18, 2022 a male Pomeranian with USDA tag number 5 was let out into the exercise yard with a male Shih Tzu with USDA tag number 18 and a female Pomeranian with USDA id 4 that was in heat. The male Shih Tzu with id 18 bit the male Pomeranian in the left front toe causing a puncture wound. The toe is swollen and red, and the fur around the puncture is discolored. The attending veterinarian was never called in regards to this bite wound and treatment recommendations for the wound.

-A Yorkshire Terrier with USDA tag number 10 had heavy brown buildup of dental plaque with reddened gums. There was a strong rancid odor coming from the mouth.

Each dealer shall establish and maintain programs of adequate veterinary care that include the use of appropriate methods to prevent, diagnose, and treat diseases and injuries.

The attending veterinarian must be contacted for an appropriate method to treat disease and injuries to prevent further veterinary complications and pain.

All live dogs shall be identified by an official tag of the type described in § 2.51 affixed to the animal's neck by means of a collar made of material generally considered acceptable to pet owners as a means of identifying their pet dogs.

All dogs must be identified by an official tag attached to the collar.

Records: Dealers and exhibitors.

- -The licensee has acquired 3 dogs that are not recorded on the 7005.
- -The licensee took in 1 dog for whelping, and another dog for breeding and there is no disposition date recorded on the 7005, and no 7006 showing where the animals went after they left the kennel.
- -The licensee has 7006 forms that show disposition of animals with just a name, and no address of where the animals went.

Each dealer shall make, keep, and maintain records which correctly disclose the following information concerning each dog or cat purchased or otherwise acquired, owned, held, or otherwise in his or her possession or under his or her control, or which is transported, euthanized, sold, or otherwise disposed of by that dealer. The records shall include any offspring born of any animal while in his or her possession or under his or her control.

Records of acquisition and disposition of all animals must be kept to ensure animals can be traced and tracked in the case of an animal disease outbreak, and to ensure that all parties are licensed that require a license.

There was a large amount of stuffing from a toy in various areas of the exercise yard.

Premises where housing facilities are located, including buildings and surrounding grounds, must be kept clean and in good repair to protect the animals from injury.

Premises that dogs have access to must be kept clean to ensure animals do not ingest objects that may cause intestinal obstruction.

3.13(a)

Veterinary care for dogs.

The program of veterinary care lists that dogs be vaccinated for rabies at 14-16 weeks, lists that heartworm and flea preventative be completed every 30 days with no medications/product listed, and there is no set frequency to examine dogs for clean and healthy eyes and dental disease. When the inspector asked about heartworm preventative the licensee produced a bottle of injectable ivermectin for cattle and swine. When the inspector asked how the medication was administered the licensee could not answer.

Each dealer must follow an appropriate program of veterinary care for dogs that is developed, and documented in writing. The written program of veterinary care must address the requirements for adequate veterinary care for every dealer that includes vaccinations for rabies, a preventative care frequency to ensure clean and healthy eyes, and teeth.

The program of veterinary care must include all aspects of veterinary care to ensure the dogs are maintained in good health.
