***An adult female King Charles Cavalier named Ruby (#992813) was licking her lips repeatedly during the inspection.

Her molar teeth were encased in tarter and her gums were swollen. There was a large ulcerated bloody area in her upper gums on the right side of her mouth. Also, this dog's right eye had a gray, thick discharge. The cornea was blue and cloudy with red specks of blood. There was a vertical ulcerated area extending the length of the cornea.

***An adult, female King Charles Cavalier named Little Red (#153649) had excessive tarter on most of her teeth. Her red, swollen gums were receding away from the teeth.

The licensee had not noticed any of these problems and they were not being treated. Teeth and/or gum problems can be painful, can affect the animal's ability to eat, and can result in tooth loss. Eye problems can progress rapidly, can be painful, and can result in loss of vision. The licensee must have these dogs examined by a veterinarian, follow the treatment recommendations, and maintain medical records for review by the inspector.
