Attending veterinarian and adequate veterinary care (dealers and exhibitors).

The attending veterinarian had not been to the premises for a scheduled visit for over 12 months and the written program of veterinary care was not available at time of inspection. Additional time was given to produce a copy of the written PVC and it still was not sent.

Annual visits by the attending veterinarian are important because veterinarians give valuable professional advice and recommendations to minimize the spread of contagious diseases and enhance the husbandry practices of the facility to maximize the health and welfare of the animals at the facility and to increase successful outcomes.

Each dealer and exhibitor shall employ an attending veterinarian under formal arrangements. In the case of a part-time attending veterinarian or consultant arrangements, the formal arrangements shall include a written program of veterinary care and regularly scheduled visits to the premises of the dealer.

Inspection Report

Records: Dealers and exhibitors.

There were no APHIS 7006 forms available at time of inspection to see where the cats had gone for adoption. The APHIS 7005 forms had not been updated to accurately determine the animals on hand. There were 106 cats listed but only 60 cats at the facility at time of inspection.

Complete and accurate records must be kept in order to ensure that each animal's identity can be known with certainty and to facilitate the tracking and tracing of animals.

Each dealer and exhibitor shall use Record of Acquisition and Dogs and Cats on Hand (APHIS Form 7005) and Record of Disposition of Dogs and Cats (APHIS Form 7006) to make, keep, and maintain the information required by paragraph (a)(1) of this section: Provided, that if a dealer or exhibitor who uses a computerized recordkeeping system believes that APHIS Form 7005 and APHIS Form 7006 are unsuitable for him or her to make, keep, and maintain the information required by paragraph (a)(1) of this section, the dealer or exhibitor may request a variance from the requirement to use APHIS Form 7005 and APHIS Form 7006.

Primary enclosures.

The vast majority of the enclosures for the sixty felines did not contain an elevated resting surface.

Elevated resting surfaces are required for cats so that they can rest above their litter pans and food bowls if they so choose. Not providing elevated resting surfaces forces the animals to remain in soiled areas of their enclosure and does not give them a chance to distance themselves from it.

Each primary enclosure housing cats must contain a resting surface or surfaces that, in the aggregate, are large enough
to hold all the occupants of the primary enclosure at the same time comfortably. The resting surfaces must be elevated,
impervious to moisture, and be able to be easily cleaned and sanitized, or easily replaced when soiled or worn. Low
resting surfaces that do not allow the space under them to be comfortably occupied by the animal will be counted as part
of the floor space.
