98112011806778 – Male leopard cat named "Cloud". This cat was squinting his left eye and has ocular discharge present in the corners of both eyes. This cat had a formed stool in the cage.

98511201180660 - Male leopard cat named "Bobby". This cat is slender and continues to have semi-formed stool.

985141005227690 – Male kitten unnamed. This cat continues to have diarrhea. This cat was also observed to have head tremors and is unsteady at times when walking. He was observed to be leaning against the wall of the enclosure at times when he walked. Inspectors verified with the attending veterinarian that he examined this kitten and directed her to treat with prednisolone and Clavamox. The licensee states that she did not treat the kitten with prednisolone and did not seek medical consultation with a veterinary specialist.

985112011806548 – Female cat "Ariel". This cat is slender. There is diarrhea in the litter box in this enclosure. This cat was examined by the attending veterinarian on 6 March 2023. Inspectors consulted with this veterinarian. He stated that

The caretaker for the facility agrees that this cat appears to be thinner. This cat was examined by the attending veterinarian on 6 March 2023. Inspectors consulted with this veterinarian. He stated that he directed the licensee to treat this cat with Clavamox and "Methigel". The licensee stated that she is not treating this cat with any medications at this time.

The attending veterinarian stated to inspectors that he directed the licensee on 6 March 2023 to treat all kittens and any that share a litter box with Albon. The licensee stated that she has not treated the kittens and the mother with this medication since that time.

Inspectors consulted with the attending veterinarian about the care of the cats in general. He stated that he directed the licensee on 6 March 2023 to treat all cats with diarrhea with azithromycin. The licensee states that she has ordered the medication and expects it to be delivered today. She had not started this medication as of the time of the inspection. The veterinarian was aware that this medication has not been given to the cats yet.

Failure to address medical problems or to treat animals as directed by the veterinarian results in ongoing disease and unrelieved suffering.

The licensee must have all of these animals examined in person by a veterinarian within 1 hour of the receipt of this report.

This inspection and exit interview were conducted with the licensee and facility representative.
