Housing facilities, general.

The facility has 4 cage carpets that are being used as whelping mats for the dogs that are excessively worn and have frayed edges. One whelping divider had excessive chew damage along the entire top edge. There are 4 outdoor runs that have chew damage present on the polyurethane steps. Chew damage in these areas can not be properly cleaned and sanitized and can cause sharp edges that can injure the dogs. Cage carpets with frayed edges can be ingested by the dogs or can cause entrapment of a limb. Correct by ensuring that all surfaces of the housing facility including houses, dens, and other furniture type fixtures and objects within the facility that can not be readily cleaned and sanitized are repaired or replaced when worn or soiled.

Exercise for dogs.

The facility does not have a written and approved exercise plan that is being followed. Failure to document and follow a written and veterinarian approved exercise plan does not allow for APHIS officials to determine if an appropriate protocol has been followed. Correct by ensuring that a written and veterinarian approved exercise plan is documented and followed.
