2.40(a)(1)

Attending veterinarian and adequate veterinary care (dealers and exhibitors).

The licensee changed his Attending Veterinarian 4-6 months ago. His current Attending Veterinarian has not filled out a new program of veterinary care. Not having the new Attending Veterinarian fill out a program of veterinary care doesn't ensure the dogs in the kennel are receiving adequate veterinary care. The licensee must have the new Attending Veterinarian fill out a new program of veterinary care for dogs. Correct by 1/2/24.

2.40(b)(3)

Attending veterinarian and adequate veterinary care (dealers and exhibitors).

During examination, a brown and white adult female Shih Tzu (ID #071) was found to have matted fur containing fecal material around the anus. The fur is being twisted due to the matting so that the skin is slightly pulled. The licensee had not observed this prior to inspection. Matted fur can cause irritation, trauma, and infection to the skin. Not doing thorough observations on a daily basis can cause the licensee to miss medical and grooming issues such as what was noted above. Correct by trimming of matted fur and provide daily observation of all animals to ensure the health and well-being of the dogs. Correct by 12/19/2023.

2.75(a)(1)

Records: Dealers and exhibitors.

The licensee has 57 adult dogs in the kennel. APHIS Form 7005 only shows that there is 44 adult dogs and is missing 13 of the adult dogs. Not having APHIS Form 7005 updated with all the current dogs in the kennel doesn't allow APHIS officials to be able to properly track all of the licensee's dogs. The licensee must update his APHIS Form 7005 to include all regulated dogs in the kennel. Correct by 12/26/23.

2.134(b)

Contingency planning.

There is no documentation showing that the contingency plan has been reviewed by the licensee in the past year. Not reviewing the contingency plan on an annual basis doesn't ensure the contingency plan adequately addresses the needs of the kennel in case of an emergency. The contingency plan must be reviewed on an annual basis. This review must be documented and the documentation must be made available for inspection. Correct by 12/26/23.

Exercise for dogs.

The licensee changed his Attending Veterinarian 4-6 months ago. The new Attending Veterinarian hasn't filled out a new exercise plan. Not having an exercise plan filled out by the Attending Veterinarian doesn't ensure the dogs are receiving daily exercise. The licensee must have the Attending Veterinarian fill out a new exercise plan. Correct by 1/2/24.

3.11(b)(2)

Cleaning, sanitization, housekeeping, and pest control.

None of the dog plastic J-type food receptacles are on a sanitation schedule. The cage surfaces and cracks surrounding the food receptacles contains buildup of food waste and dog fur debris. Cleanliness of food receptacles is important for ensuring the health of the dogs and prevention of disease. Correct by ensuring food and water receptacles are sanitized and are on a schedule for future sanitation at least once every two weeks or more often if necessary to prevent accumulation of dirt, debris, food waste, excreta, and other disease hazards. Correct by 12/26/23.
