At the time of inspection, there was no written program of veterinary care available for review.

##### **Records: Dealers and exhibitors.**

The acquisition records were incomplete. After relocating to a new site and a change of personnel, acquisition records for 10 dogs were not located at the time of inspection.

Appropriate documentation of acquired regulated animals, and complete and accurate records of disposition are essential for proper identification and necessary to track animals used in regulated activities to ensure their humane care, use, and disposition.

Every exhibitor shall make, keep, and maintain records of acquisition and disposition for each dog or cat, including animals born on the premises, and assure that all records are complete and kept as required. To be corrected by the next relicense inspection.

This is a 1st Re-License Inspection for a Class "A" license. The inspection and exit briefing were conducted with the applicant.

All items must be in compliance within 2 more inspections or by July 30, 2024 or the applicant will forfeit the license fee
