Attending veterinarian and adequate veterinary care (dealers and exhibitors).

While the facility provides deworming and ectoparasite prevention for dogs on the premises, it does not provide heartworm prevention as directed by the written program of veterinary care. Deviation from the program of veterinary care may increase risk of heartworm exposure and disease. The facility must assure the veterinarian has appropriate authority to ensure adequate care by adhering to the plan's requirements.

Attending veterinarian and adequate veterinary care (dealers and exhibitors).

The facility has administered multiple medications and supplements that were out of date, including a deworming medication with an expiration date of May, 2024 and a probiotic with an expiration date of June, 2023. The use of expired medication is not considered standard of care and could lose potency and be less effective. This could cause animals unnecessary harm or distress. The facility must correct this issue.

Exercise for dogs.

The facility does not currently maintain a written plan to provide dogs with the opportunity for exercise. While the dogs do have access to sufficiently sized runs, maintaining written procedures helps ensure these needs are met for all dogs on the premises. The facility must develop an exercise plan approved by the attending veterinarian.

Correct by July 25, 2024.
