2.50(a)(1)

Time and method of identification.

Fourteen of the adult dogs in the kennel are not properly identified by a tag, tattoo, or microchip. Not having proper identification on all adult dogs doesn't ensure the dogs can be easily identified and traced by an APHIS official. All adult dogs must be identified by tag, tattoo, or microchip. Correct by 5/16/24.

3.6(c)(1)(i)

Primary enclosures.

Five puppies were in an enclosure that measured 42" X 31" for a total of 1,302 square inches of space. Three of the puppies measured 12" and two measured 11". The five puppies together required 1,550 square inches of space. Their enclosure was short by 248 square inches of space. Cage space requirements ensure that the dogs have enough room to move about freely within their enclosures. It minimizes the dogs from stepping or sitting in their feces or urine and also minimizes the spread of disease. The licensee must ensure that all enclosures containing dogs and puppies have enough floor space to meet the minimum floor space requirements for the number of and the size of the dogs in that enclosure. Correct starting on 5/2/24.

3.13(a)(2)

Veterinary care for dogs.

A complete physical exam of all the adult dogs has not been completed in the past year. Not having the physical exams completed doesn't ensure that adequate veterinary care is being provided to the dogs. The licensee must have the Attending Veterinarian conduct annual exams on all the adult dogs. Correct by 6/2/24.

3.13(a)(3)

Veterinary care for dogs.

None of the adult dogs are current on their distemper and parvo vaccines. In addition, no dogs have been sampled for heartworm or fecal parasites in the past year. Not vaccinating all adults dogs and not sampling the adult dogs for parasites doesn't ensure the dogs are adequately protected from various diseases and parasites. All adult dogs must be vaccinated for distemper and parvo and must be sampled for parasites in accordance with a plan from the Attending Veterinarian. Correct by 6/2/24.
