Attending veterinarian and adequate veterinary care (dealers and exhibitors).

The facility failed to observe a dog in poor dental health. Upon inspection, female Cavalier #7000 was found to have hard, brown-grey material encasing 60-99% of the crown of the teeth on the upper right and left sides of the mouth. The cheek teeth (premolars) were also found to be mobile (on both sides). The gum tissue directly above the first premolar on the right and left sides are red and swollen. On the upper left side of the mouth the gum tissue is receding. The licensee reports he was not aware of the dog's dental issues prior to today's inspection. Dental issues can cause pain and distress to dogs, as well as inhibit their ability to chew properly.

The facility also failed to adequately communicate a medical issue to the Attending Veterinarian (AV). Female Cocker Spaniel #8721 was observed by the facility to have a swelling on the head a few weeks ago. The swelling is located approximately 2 inches behind the left eyeball and is approximately 1" x 1" x 1". It is firm, haired, non-panful, and has a small scab on the front surface. At the time of the inspection, the facility had not sought out medical guidance by the AV for this issue. The facility must establish and maintain a program of adequate veterinary care so that the dogs are closely observed so that their health and wellness can be assessed, and have a mechanism of direct and frequent communication of any problems then conveyed to the AV. Correct by ensuring a veterinarian is contacted to evaluate both dogs. Correct by: end of business July 1, 2024.

Veterinary care for dogs.

The facility is not following the Program of Vet Care. Two dogs are not up to date on vaccines. The licensee obtained these dogs in February 2024.

- ** Female Cocker Spaniel #6080 has no record of receiving the distemper, parvovirus or rabies vaccines.
- ** Female Cocker Spaniel #8872 has no record of receiving the distemper or parvovirus vaccines.

Distemper, parvovirus, and rabies are serious and oftentimes life-threatening viruses to dogs. Dogs affected by these viruses often suffer pain and distress. The Program of Vet Care prescribes for these vaccines to be given yearly. Correct by following a vaccination plan outlined by the Attending Veterinarian in the Program of Vet Care and approved by the vaccine manufacturer.
