##### Records: Dealers and exhibitors.

The records that the applicant provided for inspection were missing 15 dogs, and did not contain all the information as required on the APHIS form 7005. Complete and accurate records must be kept in order to ensure that each animal's identity can be known with certainty and to facilitate tracking/tracing of animals. The applicant must use a USDA form 7005 (Dogs on Hand).

#### 3.6(a)(1)

##### Primary enclosures.

In the middle kennel building, there was a wire divider between two enclosures on the west side that was rusted and broken. The broken wires can be a sharp point that can cause harm, or allow the dogs to go between enclosures. The applicant must repair or replace this divider and ensure all enclosures are safe and structurally sound.

#### 3.13(a)

##### Veterinary care for dogs.

The program of veterinary care was missing the frequency of the kennel visit and exam of each dog. It is important to have the attending veterinarian visit the kennel and exam the dogs to ensure dogs are meeting the veterinary requirements. The applicant must develop and document a veterinary approved program of veterinary care that includes kennel visits , not less than every 12 months and exams for each kennel dog.  
The program of veterinary care was missing the preventative care section. The applicant did not have the preventative care and treatment plan to ensure healthy and unmatted hair coats, properly trimmed nails, and clean and healthy eyes, ears, skin, and teeth, which are important to the dogs health. The applicant must develop and document a plan as part of the program of veterinary care.

This is a 1st Re-License Inspection for a Class A license. The inspection and exit briefing were conducted with the applicant.

All items must be in compliance within 2 more inspection(s) or by September 23, 2024 or the applicant will forfeit the license fee and must wait 6 months to reapply. Please contact your inspector to schedule your next Re-License Inspection.
