Attending veterinarian and adequate veterinary care (dealers and exhibitors).

While the facility identified and initiated treatment for 2 dogs (identified as 024 and 038) found to have skin injuries after a fight between the 2, these problems were not communicated to the Attending Veterinarian. Further, the written program of veterinary care does not provide a protocol for managing or monitoring injuries prior to veterinary consultation. Failure to notify the Attending Veterinarian regarding health problems, or failure to follow the written program of veterinary care, may affect the health and well-being of the animals. Facilities must maintain a mechanism of direct and frequent communication to convey accurate information regarding animal problems in a timely manner.

Veterinary care for dogs.

The facility does not currently maintain records documenting the dates and descriptions of new problems identified, including:

Two dogs (038 and 024) with skin injuries sustained in a fight approximately 1 week prior to inspection. The dogs were immediately separated and the resultant scabbing and hair loss to each dog's face, and the forearm of 038, have since been treated with topical petroleum jelly. The facility also does not maintain records of when treatment was applied.

One dog (003) found unable to move its hind legs. While a veterinarian was consulted and visited the facility to treat the dog, the facility does not maintain a description or record of when the problem was identified or communicated to a veterinarian.

Documentation of new problems and treatments helps assure these problems are being promptly identified and treated appropriately. Facilities must maintain records of dates and descriptions of new problems, examination findings, test results, treatment plans, and treatments administered or performed.

This inspection and exit interview were conducted with the licensee.
