The U.S. Department of Agriculture has evidence that on or about the date(s) listed below, you or your organization committed the following alleged violation(s) of Federal laws:

Date of Alleged Violation: December 20, 2023

9 C.F.R. § 2.40(b)24) Attending Veterinarian and Adequate Veterinary Care. Each dealer or exhibitor shall establish and maintain programs of adequate veterinary care that include the use of appropriate methods to prevent, control, diagnose, and treat diseases and injuries, and the availability of emergency, weekend, and holiday care.

You failed to provide adequate veterinary care for a dog that had a body condition score of three and severe dental issues. The dental issues resulted in the extraction of five teeth. The six-year-old female Dachshund "Fallon" (microchip #000010547361) was observed to be very thin, with her vertebrae and ribs easily palpated with very little fat observed around her abdomen. Fallon had a large accumulation of a gray colored material on her upper and lower teeth on both sides of her mouth, her gums in the areas are reddened and swollen. Fallon's dental record indicates she was last checked in April 2023 with no follow-up exam recorded.
