2.40(b)(2) Direct

Attending veterinarian and adequate veterinary care (dealers and exhibitors).

-A male bernadoodle (Archie 001) was prescribed medication for his ear(s) in November 2022 and then on his January 2023 physical exam was noted to have a right ear problem that was observed and treated at that time. During inspection, his right ear was observed to have drainage, matted hair under the drainage, reddened skin, and a strong odor. He was seen occasionally shaking his head during inspection. The licensee said the medication prescribed in Nov 2022 has been given to the ear since January but unknown how often it been given. Unresolved ear problems like this can cause discomfort and worsen if not treated properly. Ensure to have Archie seen by the attending veterinarian and follow the treatment prescribed, and maintain a record of treatments given to him.

***Correct by May 19, 2023.

-On the January 2023 physical exam, 5 dogs (Dallas, Lacey, Lilac, Lisa, Daisy) were noted to have otitis and/or needing feet groomed. The licensee said treatment instructions weren't obtained for the ears and some feet had possibly been groomed but when observed, had areas of matted hair. Untreated ear conditions could cause discomfort and worsen and matted hair could cause discomfort and skin problems. Ensure to contact the attending veterinarian about what treatment is necessary for the noted otitis and assist the caretaker (or contact the attending veterinarian for handling assistance if

needed) to ensure that each dogs' hair coat is maintained free from matting.

***Correct by June 01, 2023

-A red female golden-doodle (no ID) that is in the building temporarily for breeding was observed to have areas of matting on her body and was seen occasionally scratching with her hind leg. Matted hair can cause discomfort and scratching is a sign of discomfort or could be a sign of something causing an unhealthy skin condition. Hands-on observation found the area she was scratching was matted, however skin couldn't be seen with the matted hair. To protect all the dogs in the facility, ensure that this dog's hair coat is free from matted hair and have her seen by the attending veterinarian if after groomed she continues to scratch at herself.

***Correct by May 19, 2023.

2.51(b)(2)

Form of official tag.

The facility has a new license number and the identification tags on dogs have the previous license number on them. Also, at least 3 adult dogs were seen to not have their tags on them. Identification tags are important for husbandry tracking purposes and must contain the license number. Ensure that each dog has tags with the new license number.

***Correct by August 31, 2023.

2.75(a)(1)

Records: Dealers and exhibitors.

APHIS 7005 Record of Acquisition and Dogs on Hand was incomplete. 22 adult dogs were observed in inspection, however the facility APHIS 7005 listed 14 dogs. APHIS 7005 is required to be maintained up to date and can be important for animal health tracking. Ensure to update APHIS 7005 fully and correctly with the required information.

Veterinary care for dogs.

The written program of veterinary care does not have frequency for fecal tests (for intestinal parasites) and heartworm sampling. Routine sampling for intestinal parasites and heartworm is required and helps protect all the dogs. Ensure that the written program of veterinary care is updated to include intestinal parasite and heartworm sampling per the attending veterinarian's guidance and then maintain records of test results done.
