Time and method of identification.

Adult dogs do not have official identification and do not have identification numbers (although the facility does know each by name and have records using dogs' names). Official identification and numbers for each dog are important for husbandry records and required for licensed facilities. Ensure that official identification is assigned and attached safely to each adult dog in the facility.

Records: Dealers and exhibitors.

The adult dogs were not listed on APHIS 7005 Record of Acquisition of Dogs and Cats on Hand. Complete records of acquisition can be important for husbandry and health tracing and is required to be maintained on APHIS 7005. Ensure each adult is listed with complete information on APHIS 7005.

Housing facilities, general.

A pallet with about 5 bags of food are stored in the same room as the dogs. Also an open bag of bedding is in a tote but the tote doesn't have a lid. Only food or bedding currently being used may be kept in the animal areas if in leakproof containers with tightly fitting lids. Unopened bags not in use have to be stored in a different space (not in the same room as the dogs), off the floor and away from the walls, to allow cleaning underneath and around the supplies. Ensure that food and bedding is stored properly to prevent it from getting dirty (contaminated) from the animals in the room.

Veterinary care for dogs.

The facility has an attending veterinarian for dogs that regularly visits the dog area and is following a vaccination and deworming schedule, however does not have a written Program of Veterinary Care (PVC) that is signed by the attending veterinarian. A written PVC is required and helps APHIS officials determine if adequate veterinary care is being provided. Ensure that written Program of Veterinary Care is developed and followed and is available for inspection.
