#### Attending veterinarian and adequate veterinary care (dealers and exhibitors).

A bottle of Pyrantel dewormer and a bottle of Panacur/Safeguard did not have an expiration date present on the label from the veterinary clinic. The facility was unsure of when they received the bottle of Pyrantel and Panacur/Safeguard.

Medical products missing expiration date information does not ensure that the product is still effective at treating illnesses and the health of the animal may suffer. Each dealer shall use appropriate methods to prevent, control, diagnose, and treat diseases and injuries. The facility must ensure medical products have an accurate expiration date at all times. The facility discarded the medical products at the time of inspection.

### Time and method of identification.

There are 2 puppies each with their respective nursing dam, that have no official identification. Official identification is necessary for APHIS officials to be able to trace animal movements. The licensee must assign an official identification number to each of these dogs and any future dogs born at the facility in timely manner after their birth.

Records: Dealers and exhibitors.

The facility documents the acquisition information for the adult dogs on APHIS 7005 (Record of Acquisition for Dogs). 8 adult dogs were listed, 4 of those dogs had been sold but not updated with the date they were sold. The inspector counted 15 adult dogs, 11 of which are not listed on the APHIS 7005.

Acquisition information is necessary for APHIS officials to make positive identification of animals during inspection and to properly trace their movements.

The facility shall make, keep, and maintain an approved method of documentation which fully and correctly disclose all information concerning each dog purchased or otherwise acquired, owned, held, or otherwise in his or her possession or under his or her control, or which is transported, euthanized, sold, or otherwise disposed of by that dealer. The facility must ensure all required acquisition information for each dog is properly and accurately documented at all times.

Each dealer shall make, keep, and maintain records that fully disclose the official identification number of each animal.

The licensee must ensure that the acquisition and disposition records for each puppy contains a unique identification

number.

Housing facilities, general.

There is 1 inch by 1 inch plastic coated wire added to the caging bars of an enclosure housing 3 adult King Charles Spaniels. The wire is in disrepair and has at least 3 sharp points at least 2 inches long that are at the dog's eye level. The

inspector observed one dog chewing on the wire and stripping the plastic coating off with its teeth.

Sharp metal points in an enclosure may result in lacerations or serious injury to the dogs eyes or mouth. Housing facilities

must be kept in good repair, and they must protect the animals from injury. The facility must repair the enclosure so that it

is kept in good repair and is safe for the dogs.

The facility is currently keeping the wood shaving bedding in the open bag inside a plastic crate without a lid. Unopened bags of dog food are currently being stored on the floor of a vacant indoor dog kennel.

All open bedding must be kept in a leakproof container with a tightly fitting lid. All unopened bags of dog food must be
stored off the floor and away from the walls, to allow cleaning around and underneath. These storage practices are
needed to prevent spoilage, contamination and vermin infestation. The facility must place the wood shaving bedding into
a container with a tightly fitting lid and store the unopened dog food off the ground and away from the walls.
