## 3.1(c)(2)

#### Housing facilities, general.

\* A missing section of fiberglass wall board that is attached to an entrance door was observed. Seven dogs are in contact with the affected wall board located in outdoor housing. A chewed, roughened surface could harbor disease causing agents which affects the health and well-being of the dogs. The open area between the fiberglass and wood wall could serve as a collection area for dirt, hair, fecal waste, or other debris. Roughened surfaces cannot be readily cleaned and sanitized. All surfaces of housing facilities must be maintained on a regular basis. The licensee must ensure all surfaces are always maintained on a regular basis or be replaced when worn that cannot be readily cleaned and sanitized. Correct by 5/22/23.

#### 3.1(c)(3)

## Housing facilities, general.

\* There is a mixture of dirt, grease and other excreta accumulating on the interior wood wall in two outdoor sheltered structures and the interior fiberglass wall in one enclosure. Fifteen dogs are in contact with the affected surfaces located in outdoor housing. Three dogs are in contact with the affected surface located in sheltered housing. The affected area covers approximately 60 to 75 percent of the interior wall area. Licensee stated that the interior of the outdoor sheltered housing gets cleaned once a year in the spring. Cleaning of surfaces is necessary to prevent an accumulation of excreta and other disease hazards. This indicates an unsanitary living condition exists that could lead to potential disease or

health risks. Surfaces which are not cleaned and sanitized properly increase the risk of disease hazards for the dogs. Cleanliness is important to the health and well-being of the animals. All surfaces of housing facilities must be cleaned and sanitized when necessary to satisfy generally accepted husbandry standards and practices. The licensee must ensure that hard surfaces with which the dogs come in contact must be spot cleaned daily and sanitized in accordance with 3.11 (B) of this sub part to prevent accumulation of excreta and reduce disease hazards. Correct by 5/10/23.

### Outdoor housing facilities.

\* Three outdoor enclosures housing 20 dogs have no shade available for the dogs. Lack of adequate shade from the direct rays of the sun can be stressful causing discomfort creating a potential negative impact on the health and well-being of the dogs. In addition, dogs do not have the ability to regulate their internal temperature which could lead to the dogs becoming overheated. The licensee must ensure that shade is provided and be large enough to contain all the dogs at one time and protect them from the direct rays of the sun. Correct by 5/22/23.

# 3.13(a)(3)

#### Veterinary care for dogs.

\* There was no recorded date for annual rabies vaccination for 39 dogs. Licensee stated that all dogs are given rabies vaccination shots in the spring. Annual rabies vaccinations are important for the health of the animals. The licensee must ensure that all dogs are receiving vaccinations for contagious and/or deadly diseases of dogs (including rabies, parvovirus, and distemper) and sampling and treatment of parasites and other pests (including fleas, worms, coccidia, giardia, and heartworm) in accordance with a schedule approved by the attending veterinarian. Correct by 6/8/23.
