#### Housing facilities, general.

Some rust has developed on the gated fence panels of the outdoor runs of the sheltered housing facility, most commonly near the floor. Effective sanitization cannot be achieved on rusty surfaces, exposing the dogs to disease hazards.

Surfaces that come in contact with the dogs must be free of excessive rust that prevents required cleaning and sanitization.

This is a 1st re-license inspection for a Class "A" license. The inspection and exit briefing were conducted with the applicant.

All items must be in compliance within 2 more inspections, or by July 4, 2022, or the applicant will forfeit the license fee and must wait six months to re-apply. Please contact your inspector to schedule your next re-license inspection.
