A red male poodle no longer had his tag (#101). The representative looked for it but couldn't find the tag. Identification can be important for animal health and husbandry tracking. Ensure that this dog's tag is found or assign it a replacement tag so that it is properly identified.

##### Housing facilities, general.

The exercise area (by the north walk-in gate) has some strands of loose wire and wire points that the dogs could contact when let out into it. Wire strands and points could hurt dogs. Ensure to maintain surfaces free from edges or points that could injure the animals.

##### Housing facilities, general.

A bag in the shavings storage shed has bird droppings on it. It appears that there is a nest above the bag. Contamination of bedding/shavings with bird droppings could make dogs sick. Ensure to protect shavings from

#### 3.13(a)(2)

##### **Veterinary care for dogs.**

The last physical exams of adults from the Attending Veterinarian were noted on 1/3/2022. The representatives said that the noted wellness checks on 1/3/2022 were the last time physical exams by the attending veterinarian were done.

Yearly physical exams on each dog are required and help ensure each dog is healthy. Ensure that a complete physical examination from head to tail of each dog by the attending veterinarian is completed.

#### 3.13(a)(3)

##### **Veterinary care for dogs.**

The facility representative said that the veterinarian has done rabies vaccinations for adults but a schedule for parvo and distemper vaccination has not been followed for adults (puppies are being vaccinated per records). Also, the written program of veterinary care does not address sampling for heartworm and fecal sampling for adult dogs. Vaccination for parvo and distemper is required for adult dogs and helps protect the facility from these diseases. Sampling for heartworm and fecal sampling of adults is required and helps ensure the facility is preventing parasites. Ensure to follow the attending veterinarian's program of vaccination and contact the attending veterinarian to update the sampling plan for heartworm and fecal tests and then follow the program of sampling.
