The facility had several expired products; GI Synbiotics paste expired 03-March-21, Bottle of Oxytocin expired August 2018 and Esbilac puppy milk replacement powder expired April 2021. Expired products have reduced effectiveness in treating animal medical problems. The facility discarded these products at the time of inspection.

Time and method of identification.

There are 2 Pomeranians and 1 Dachshund that are approximately 6 months old and have no official identification.

Official identification is necessary for APHIS officials to be able to trace animal movements. The facility must assign an official identification number and place it on the dogs.

There are 2 Pomeranians puppies approximately 8 weeks old and have no official identification. Official identification is necessary for APHIS officials to be able to trace animal movements. The facility must assign an official identification number to each of these dogs.

There are 2 Pomeranians and 1 Dachshund that are approximately 6 months old and are not listed on the facility's Record

of Acquisition and Dogs on Hand (APHIS Form 7005). Record of Acquisition and Dog on Hand forms are necessary for

APHIS officials to track animal movements. The facility must make, keep, and maintain the acquisition information for all

dogs on the premises at all times.

3.13(a)(3)

Veterinary care for dogs.

The facility is missing information on the routine for heartworm testing and fecal sampling. There is no guidance currently

provided in their program of veterinary care for the percentage or total number of dogs to be sampled and the frequency

of which they should be tested for heartworm and intestinal parasites.

Heartworm disease is caused by a parasite that can cause significant damage to the heart before visible symptoms are

seen. Likewise, intestinal parasites can cause chronic disease that can be difficult to detect. Intestinal parasites can also

be spread from mother to puppies. Because of these risks to the health of dogs and puppies, regular testing in necessary

to ensure control and early detection.

The facility's Program of Veterinary Care provides a schedule for adult dog rabies vaccinations. It states adult dogs will be

vaccinated annually for the first rabies vaccine and then every 3 years. 7 dogs are overdue for their rabies vaccinations;

Dixie, Christa, Breanna, Bella, Beauty, Frisky and Fluffy. Maintaining a vaccination schedule is necessary to ensure the

dogs are protected from contagious and deadly diseases.

Each dealer must follow an appropriate program of veterinary care for dogs that is developed, documented in writing, and

signed by the attending veterinarian and includes sampling and treatment of parasites and other pests and a vaccination

The facility must vaccinate the dogs that are overdue for the rabies vaccine or provide a statement from the veterinarian if the dogs are not able to be vaccinated at this time.
