Housing facilities, general.

A cable is hanging down into one enclosure that needs to be secured for the safety of the dogs. An enclosure adjacent to this one has chain link that is no longer secured at the base of the enclosure and is protruding into the enclosure. These two items need to be addressed to keep the enclosures in good repair and for the safety of the dogs.

3.1(c)(1)(i)

Housing facilities, general.

Several of the support beams for the outdoor enclosures are showing signs of rust where the doors are connected to the concrete and a few of the sections are rusted through creating sharp edges and impacting the structural integrity of the frame. One metal support bar along the far enclosure is rusted out underneath the bar creating a sharp edged area 12 inches long. Another metal beam coming down vertically is rusted through near the ground creating a gap with sharp edges in the metal. These sections of the primary enclosures must be addressed to keep the enclosures in good repair and for the safety of the dogs.

This is a 1st Re-License Inspection for a Class "A" license. The inspection and exit briefing were conducted with the applicant.
