#### 2.40(b)(2)

##### Attending veterinarian and adequate veterinary care (dealers and exhibitors).

There are 2 containers of medications on a cart in the kennel that are not suitable for use. A bottle of pyrantel pamoate expired 05/2023. A container of Probios expired 10/26/2018. The licensee reports the container no longer holds Probios, but rather another product, of which the name and expiration date are not transcribed onto the container. The product appeared as a dark grey, clumpy powder. Expired or improperly labeled medications can be dangerous as the efficacy, potency, and freshness cannot be confirmed. If the medications are no longer effective, normally preventable diseases may become a problem. Correct by ensuring that all medications are properly labeled and not expired, so the licensee is able to use the appropriate methods to prevent, control, diagnose, and treat diseases. Corrected at the time of the inspection.

#### 3.6(a)(2)(iii)

##### Primary enclosures.

The primary enclosure failed to contain an animal securely. A female Golden Retriever (Lisa #3596) escaped from her outside enclosure during the inspection. She climbed up the front gate and squeezed herself between the top bar of the gate and some loosened wire paneling. The dog was recovered almost immediately after escape, and she experienced no harm. However, loose dogs are at an increased risk for injury or serious accidents such as being hit by a car, consuming toxins, or other events which may lead to pain, distress, or even death. The licensee used Zip ties to fix the enclosure. Correct by ensuring that primary enclosures be designed and constructed so that they are structurally sound and maintained so that they can contain the animals safely. Corrected at the time of the inspection.

#### 3.10(a) Direct

##### Watering

Water was not available to two dogs at the time of the inspection. A male Golden Retriever (Mika #3794) and a female Golden Retriever (Lisa #3596) had an empty bucket in their outside enclosure. The license said he forgot to fill it when he was doing chores this morning. The dogs were both very active. When they were given fresh water to drink, they both drank eagerly from the same bucket at the same time for at least 2 minutes. They both went back to the bucket several times for additional water. Today's ambient temperature at the time of inspection was approximately 82 degrees F. In hot weather, dogs need water to regulate their body temperature by panting and drinking water. Without water they may

become dehydrated or can even experience heat stress and possible death. Correct by ensuring potable water is continuously available to dogs. Corrected at the time of the inspection.

### 3.13(a)(4)

#### Veterinary care for dogs.

A female Pomeranian (Trixie #3313) and a female Golden Retriever (Ashley #9716) had heavy matted hair behind both ears. Trixie also had a few mats along her topline. Matted hair can cause skin irritation or may be an indication of an underlying skin or ear issue. A regular grooming schedule should be part of a preventative care program to ensure healthy and unmatted hair coats. Corrected at the time of the inspection.

This is a 1st Re-License Inspection for a Class "A" license. The inspection and exit briefing were conducted with the applicant.

All items must be in compliance within 2 more inspections or by September 15, 2023, or the applicant will forfeit the license fee and must wait 6 months to reapply. Please contact your inspector to schedule your next Re-License Inspection.

Regulated activity can continue under your existing USDA license until it expires.
