**Attending veterinarian and adequate veterinary care (dealers and exhibitors).**

At the time of inspection there were several kittens that were displaying signs of illness that were either due, or past due, on their FVRCP vaccinations, and had yet to be seen by a veterinarian. The symptoms for the following kittens ranged from yellowish-brown crust built up on nostrils, clear nasal discharge, frequent sneezing, and/or watery eyes: 6 Bengal kittens (that had yet to be microchipped) housed in the white cage near the window in the living room; 4 Bengal kittens (Microchip #'s: 985141005790884, 985141005790195, 985141005791045, and 985141005790573) in the white cage near the kitchen in the living room; 3 Bengal kittens (Microchip #'s: 985141005790456, 985141005790202, and 985141005794887) housed in a tall black cage near the kitchen, immediately adjacent to the white cage; and 3 Bengal kittens (Microchip #'s: 985141005790417, 985141005794471, and 985141005790930) housed in a tall black cage in the living room near the back hallway. There was a Leopard cat kitten (not microchipped) - housed in the second room to the left off the hallway- that had active diarrhea (liquid consistency dripped along sides of water bowl and semi-solid clumps adjacent to the water bowl inside of its litterbox), lethargy, shallow breathing, and cloudy eyes with squinting and clear discharge from both. The latter kitten was being treated by the licensee after it stopped eating the week before (started eating again this week), but like the other kittens, had yet to be examined by a veterinarian. Failure to follow appropriate methods to prevent, control, diagnose and treat diseases can negatively impact the overall health and well-being of the animals, and could possibly lead to avoidable suffering and death. Each dealer must establish and maintain programs of adequate veterinary care that include the use of appropriate methods to prevent, control, diagnose, and treat diseases and injuries. All kittens must be examined and treated by a veterinarian by the end of the day.

This inspection and exit interview were conducted with the licensee.
