#### 3.13(a)

##### Veterinary care for dogs.

The licensee did not follow the Program of Veterinary Care related to the administration of anti-parasitic drugs for intestinal parasites to adult dogs. The Program of Veterinary Care, signed and dated 1/7/2022, called for the administration of Fenbendazole twice per year (approximately 6 months apart) and the administration of toltrazuril twice a year (approximately 6 months apart). The Fenbendazole and Toltrazuril administration were to be separated from each other by approximately 3 months. However, the licensee stated that he was administering both the fenbendazole and the toltrazuril medication to the adult females after whelping, at the time he was administering these medications to the puppies. Therefore, the adult females were receiving both the fenbendazole and the toltrazuril anti-parasitic medications within about 4 to 6 weeks of each other.

Failure to follow the Program of Veterinary Care can lead to harm to the animals from the inappropriate administration of medication or the development of illnesses that the Program of Veterinary Care is meant to prevent.

The licensee must follow the Program of Veterinary Care for dogs that is developed, documented in writing, and signed by the attending veterinarian.

#### 3.13(b)

##### Veterinary care for dogs.

Certain medical records were not maintained for dogs sold and held by the licensee. The written Program of Veterinary Care, signed and dated 1/7/2022, required yearly vaccination of adult dogs with a 5-way vaccine (Distemper, Adenovirus 1 & 2, Parvovirus, & Parainfluenza), monthly administration of heartworm prevention, and a detailed weekly preventative health care exam (which includes examination of the eyes, ears, skin, teeth, nails, & haircoat). The licensee stated that he was administering the yearly 5-way vaccination, giving the monthly heartworm prevention, and performing the weekly preventative health care checks; however, he sometimes neglected to document these activities. At the time of the inspection, there were no records of yearly 5-way vaccination of adult dogs, there were no records of administration of heartworm prevention in the month of June 2024, and there were no records of weekly preventative health care exams in the month of October 2024.
