Housing facilities, general.

* Two outdoor enclosures have compact earth flooring. One of these enclosures was located outside housing two adult dogs and the other inside a large shed housing seven puppies. The dogs are digging two large holes underneath their dog house in one enclosure. One of these large holes had paneling to prevent digging that was exposing sharp points. Puppy's enclosure had three holes being dug under the side wall and and under the chain link fencing for the enclosure. These holes were anywhere from approximately 1/2 ' wide to 2 ' long. The maintaining the repair of dug holes in the compact earth near the fencing, building side wall and dog house indicates these enclosures are not being kept in good repair. This can allow for the dogs to escape or get injured while trying to escape.

For the prevention of injury to the two adult dogs and seven puppies, all housing facilities must be kept in good repair.

3.11(a)

Cleaning, sanitization, housekeeping, and pest control.

* Three outdoor enclosures, all housing three adult dogs and seven puppies, have compact earth floors. Two of these enclosures were located inside a large shed. All these enclosures had an accumulation of fecal waste on the compact earth floors. One enclosure had panel used to prevent the dogs from digging out that had an accumulation of fecal waste within the panel openings. The waste was brown to grey in color and dry indicating the excrement is not being removed from the enclosures daily. This can increase the disease hazards, insect and pest infestation.

For the prevention of an accumulation of fecal waste, disease hazards and the reduction of insects and pests, all primary enclosure's must have daily removal of fecal and food waste.

Four enclosures inside the large shed all housing, three adult dogs and seven puppies, have an accumulation of item(s) on the ground around their enclosures.

These item(s) are electrical cord, hoses, two 12V batteries, plastic bags, equipment and bags full of material. This can attract and provide breeding areas for rodents, and pests and vermin. This does not facilitate cleaning of the premises. Potentially, this can affect the health and well-being of the dogs.

For the protection of the health and well-being of the dogs, weeds must be controlled to facilitate cleaning. Similarly, all premises must be free of equipment, batteries, plastic and other discard matter, therefore preventing breeding and living areas for rodents, and other pests and vermin.
