## Records: Dealers and exhibitors.

The facility is not maintaining adequate records of acquisition and disposition. Cage cards are used for acquisition records for litters of puppies; however, they do not contain all of the required information such as: USDA license number, individual puppy identification numbers, gender of each puppy, color, breed, and date of disposition as required by the Animal Welfare Act Regulations subpart 2.75(a)(1)(i-ix).

Additionally, not all of the APHIS 7006 Record of Disposition forms evaluated during the inspection are being filled out completely. Approximately 15 forms from 2023 and 2024 were missing required information found in the Regulations under 2.75(a)(1)(i-ix), such as the date of disposition, the name and address of the person who purchased the dog and whether or not that person is licensed under the Act, the vehicle license number and State and the driver's license number of the person who purchased the dog, method of transportation, and the method of disposition (sale, donation, etc).

Accurate record keeping is essential so that APHIS inspectors can adequately identify the movement of dogs into and out of the facility, especially in cases of loss or theft. Each dealer shall make, keep, and maintain records for forms which fully and correctly disclose the information concerning each dog purchased or otherwise acquired, owned, held, or which is transported, sold, or otherwise disposed of by that dealer. The records shall include any offspring born to any animal while in his or her control. Correct by maintaining complete records for acquisition and disposition by December 25, 2024.

## Veterinary care for dogs.

The licensee is not following the Program of Vet Care (PVC) for vaccinations in adult dogs. The Animal Welfare Act (AWA) requires vaccinations for contagious and/or deadly diseases of dogs, including rabies, distemper, and parvovirus. The facility's PVC prescribes for the rabies vaccine to be given according to label directions, and for the distemper and parvovirus vaccines to be given yearly to adult dogs. None of the adult dogs at the facility are up to date on all three of the vaccines required by the AWA, nor do they have a prior history of vaccines.

Failure to follow the PVC for vaccinations leaves the dogs susceptible to diseases, which, if contracted, would cause pain, distress, and suffering. It is also important for breeding dogs to be vaccinated because they will pass immunity from

vaccines onto their offspring. Correct by administering all of the vaccines required by the Animal Welfare Act (distemper, parvovirus, and rabies) in accordance with a schedule approved by the Attending Veterinarian and vaccine manufacturer recommendations. Correct By: January 15, 2025, onward.

## Veterinary care for dogs.

The facility has not retained copies of all medical records. The facility reports yearly fecal testing was completed during the kennel inspection by the Attending Veterinarian, with the most recent being completed on 4/24/24. However, the facility does not have a copy of the results for any of the fecal samples. Maintaining medical records assists APHIS inspectors in confirming adequate veterinary care is being provided to the regulated dogs at the facility. Dealers must keep copies of medical records for dogs, including the dates and findings/results of all screening, routine, or other required or recommended test or examination. Correct by: December 25, 2024, onward.
