3.13(a)(3)

Veterinary care for dogs.

The applicant is not following the vaccination and sampling schedule in the written Program of Veterinary Care (PVC):

- All adult dogs are not up to date on their Distemper and Parvovirus vaccinations, a required vaccination. The adult dogs last received the Distemper and Parvovirus vaccines on March 29, 2023. The Program of Veterinary Care prescribes for these vaccines to be given yearly.
- Sampling for intestinal parasites for adult dogs is not being performed. The PVC states that 10% of all adult dogs will be tested yearly.

Failure to administer required vaccines in accordance with a veterinary approved schedule leaves the dogs susceptible to Distemper and Parvovirus, which if contracted, can cause pain, distress, and suffering. Failure to follow a schedule for parasite sampling may cause the animals to not be adequately protected from diseases and parasites. Correct by ensuring all animals are vaccinated in accordance with the guidelines and schedule approved by the Attending Veterinarian and follow the schedule for parasite sampling. Correct by 18-NOV-2024.

3.13(b)(3)

Veterinary care for dogs.

The licensee does not maintain medical records for all adult dogs. Records indicate that 4 adult dogs have no medical records, the Licensee states that these animals did receive Distemper and Parvovirus vaccines last year:

- Adult Female Cavalier King Charles Spaniel (#8498), Adult Female Cavalier King Charles Spaniel (#6068), Adult Female Cavalier King Charles Spaniel (#2219), and Adult Female Labradoodle (#5805).

Failure to maintain adequate medical records may interfere with the ability of APHIS officials to determine if the animals are receiving adequate veterinary care. Complete medical records must be maintained and include the names of all vaccines and treatments administered and the dates of administration. Correct by documenting all treatments given and ensure that medical records are complete and contain the required information. Correct by 11-NOV-2024.
