A silver, black, white, and brown (Blue Merle) male Welsh Corgi (\# 054) had an open wound on it's left ear. The wound was oozing a yellowish mucousy substance from the ear. The licensee stated the dog got into a fight three days ago. He has been trying to treat it himself, but has not contacted the Attending Veterinarian.

An open wound may be painful for the dog. In addition, if not treated correctly, it could become infected and cause further problems.

The Attending Veterinarian must be contacted and the dog must be treated per the Attending Veterinarian's instructions.
