***In two outdoor exercise enclosures where eight dogs routinely play, there were two wood climbing structures that were in disrepair. The edges of the wood climbing structures had jagged, splintered edges and one had many exposed nails that were protruding out of the wood where the animals could come into contact with them. Also, there were broken wood pieces in the yard of one enclosure. The licensee stated the dogs routinely chew the wood slats of these climbing structures.

***In one of the outdoor exercise enclosures, the bottom of the chain linked fence in two areas were curled up and created sharp points that were pointing into the enclosure. Sharp points present a physical hazard that could result in injury to the animals.

Housing facilities must be free of sharp points and jagged sharp edges. The licensee must alter the sharp points in a manner that eliminates the risk of injury to the dogs. The licensee must ensure that all enclosures are safe for the dogs at all times.
