Contingency planning.

* No copy of the contingency planning program was available for review during the inspection. The contingency plan is important to go over & discuss before an emergency takes place. The applicant must develop, document, and follow an appropriate plan to provide for the humane handling, treatment, transportation, housing, and care of their animals in the event of an emergency or disaster (one which could reasonably be anticipated and expected to be detrimental to the good health and well-being of the animals in their possession). 3.6(c)(1)(i)

Primary enclosures.

* Minimal floor space was not being provided for four adult dogs and four puppies. The calculation is: (length of dog in inches + 6) = required floor space in square inches. Required floor space in inches/144 = required floor space in square feet. The dog shall be measured from the tip of the nose to the base of the tail while in a normal standing position. If any dog is being singly housed, then that dog will require two times its required floor space. 1) One weaned puppy measuring 19 inches in length was being housed in a 24 by 72 inch enclosure. $19 + 6 = 24 \times 24 = 576$ sq. inches / 144 = 4 sq. feet. There were 4 puppies in this enclosure at the time of inspection. $4 \times 4 = 16$ sq. ft. of floor space needed. $24 \times 72 = 1,728$ sq. inches / 144 = 12 Sq. ft. of provided floor space. These puppies are 4 sq. ft. short of meeting its minimal floor space requirement.

2) One weaned puppy measuring 17 inches in length is being housed in an enclosure that measured 24 by 36 inches.
17 + 6 = 23 x 23 = 529 sq. inches / 144 = 3.67 sq. ft. of minimal required floor space. There were 2 puppies in this enclosure requiring 7.34 sq. ft. of floor space. 24 x 36 inches = 864 sq. inches / 144 = 6 square footage of floor space being provided. These 2 weaned puppies are 1.34 sq. ft. short of meeting the minimal floor space requirement.
Lack of minimum floor space can affect the freedom of movement affecting the health and well-being of the animals.
Insufficient floor space or exercise room can cause behavioral and physical stresses on the animals. Adequate floor space that allows sufficient freedom of movement to make normal postural adjustments is necessary to ensure the health and well-being of all dogs. The licensee must ensure that all animals have no less than the minimum floor space as required by this section so that they can make normal, postural adjustments and for their and comfort and well-being.

Exercise for dogs.

* There was no written exercise plan for the 69 weaned puppies at the time of inspection. This helps to ensure the minimum floor space requirement is being met. Minimal floor space is necessary for the physical health and well-being of all dogs housed at the facility. The licensee must develop an exercise plan with the attending veterinarian that documents the frequency, method, and duration of exercise for each animal. The plan must ensure that all animals are receiving an adequate opportunity for exercise and physical movement. This plan must be approved by the attending veterinarian and must be made available to the APHIS inspector upon request. Correct by 5/18/23.
