Watering

Eight adult dogs have 20 oz cans for watering receptacles. These containers are small and narrow and do not allow the dogs to have water continuously available. The applicant was working on completing the continuous water system during inspection. Ensure that if containers are used for water that they are large enough to provide continuous access to potable water or ensure that the continuous water system functioning for all dogs.

3.13(a)

Veterinary care for dogs.

The written program of veterinary care lacks detail on a few items:

-A plan for sampling of intestinal parasites (fecal sampling) is not in place;

-Dosing instructions (amount and route) for toltrazuril and pyrantel are not described in the program or labeled on the medication bottles.

-The facility vaccinates puppies with Intra-trac3 but the vaccinating schedule for this vaccine is not on the PVC approved by the attending veterinarian.

Complete and clear written plans for these items are needed to ensure that dogs are receiving the treatments as guided
