Housing facilities, general.

The kennel for "Clifford's," microchip# 7000000100278 had generalized flaking rust on the metal bars. Hair and organic material were stuck on the areas with rust. Rust can prevent proper cleaning and sanitization of primary enclosures, as well as lead to damage to the structural integrity. Interior surfaces and any surfaces that come in contact with dogs must be free of excessive rust. Correct by 6/1/22.

Primary enclosures.

Two primary enclosures contained damaged floors. The floor tray for "Ben's," microchip# 900215002445098, primary enclosure had a jagged-edged deficit that spanned the entire front of the kennel. The floor tray for "Clifford's," microchip# 7000000100278, primary enclosure had a jagged-edged deficit in the front of the kennel that was approximately 12
