Feeding

A female Shih Tzu, "Jada" (no id) was in the whelping box nursing puppies. She was thin and her ribs, lumbar vertebrae and pelvic bones were easily visible, with no palpable fat. The licensee states that she is on a higher quality dry puppy food, but based on her condition and the nutritional needs she requires to nurse puppies, additional supplementation of nutritive value should be provided to maintain the normal condition and weight of the animal during this life stage.

Another female Shih Tzu, "Glorianna" #260 who is pregnant and due to whelp soon was also thin and her ribs, lumbar vertebrae and pelvic bones were easily visible, with no palpable fat. This dog is also on higher quality dry puppy food, but based on her condition and the nutritional needs she requires to nurse puppies, additional supplementation of nutritive value should be provided to maintain the normal condition and weight of the animal during this life stage.
