Ensure that each dog has their official identification recorded on the adult dog list (APHIS 7005) and that each dog is wearing their official identification number as required.

Watering

Three enclosures had water containers that were empty. The licensee reported watering chores were completed in the morning. The time of inspection was right before normal afternoon chore time which would include filling and refreshing water containers. When dogs were brought water they all drank water in a manner suggesting they were moderately thirsty. Empty water containers do not ensure dogs have adequate drinking water and adequate water is necessary for dogs to stay healthy. Potable water must be continuously available for dogs, unless restricted by the attending veterinarian. For their health, ensure that water containers are checked and filled often enough to ensure dogs have

3.11(b)(2)

Cleaning, sanitization, housekeeping, and pest control.

The doors between the indoor/outdoor areas for dogs had a build-up of brown material on them. A build-up of brownish material could spread sickness in the building. The indoor surfaces that dogs contact need to be cleaned and sanitized often enough to prevent a buildup of material. Ensure to include the door surfaces in the cleaning and sanitizing routine and ensure they are cleaned and sanitized at least once every 2 weeks or more often if needed to prevent a build-up of material.
