##### Contingency planning.

#### **Veterinary care for dogs.**

The form had been started and a vet visit was scheduled but the visit had not yet occurred. A written program of veterinary care for dogs including regular scheduled visits, complete physical exams, vaccinations, parasite sampling and control, preventative care and treatments, is important to ensure adequacy of veterinary care for all dogs. Correct by developing a written program of veterinary care for dogs that is approved and signed by the attending veterinarian.

This is a 1st Re-License Inspection for a Class B license. The inspection and exit briefing were conducted with the applicant.
